- It works well with phenols and epoxies but may also work with polyurethanes and acrylics.

How To Use

As a primer dilute to 10% solids in water or IPA and apply by dipping or brushing.

DOWSIL™ Z-6137 Silane should be added during the final thinning stage at concentration of 0.5–3.0 wt%. If fillers, silicas or pigments are present higher levels may be needed as the silane may preferentially absorb onto these surfaces.
